**arbitrators' fees
and costs of the
arbitration**

Pending any award by the arbitrator allocating the costs of the arbitration, the parties agree that the arbitrators' fees and disbursements incurred by the arbitrator shall be paid as follows:

- The parties shall meet the arbitrator's fees and disbursements equally.
- The parties have agreed that they meet the arbitrator's fees and disbursements in the following proportions: the Claimant will pay _____ % and the Respondent will pay _____ %.

The parties agree that the costs of the arbitration (including the arbitrators' fees and disbursements) shall be dealt with as follows:

- The arbitrator shall determine the allocation of the costs of the arbitration in accordance with the provisions of the rules chosen by the parties.
- The parties have agreed to bear their own costs of the arbitration and do not agree that the arbitrator should determine the allocation of the costs of the arbitration.

Nothing in this clause affects any contractual right of an arbitrator to payment of his fees and expenses.
